Entries postmarked by entry due date will be accepted. **No late entries will be accepted!** Exhibitor may list only the animals to be shown plus one alternate animal per species. Be sure to designate which animals are alternates. Do not list additional alternates. The tag number and alternate tag number must be specified on the exhibitor entry form to be eligible. **Entry fees and grounds fees (\$5.00 grounds fee per exhibitor) must be included with this entry form or the entry will be disqualified. Please pay with a check only—no cash.**
